1.3 CRITERIA WISE SUMMARY

Curricular Aspects

Sinhgad College of commerce is affiliated to the SPPU and follows the curriculum stated by the university. SCOC focuses on the academic programs offered by the SPPU. The college ensures effective curriculum delivery through a well-planned and documented process. The SCOC adheres to the academic calendar for the conduct of Continuous Internal Evaluation (CIE). Faculty of the Institution participates in the activities related to curriculum development and assessment as well as syllabus designing, paper setting, practical/ oral exams, etc. Faculty members participate in Workshops on Curriculum Design conducted by the university and organize Faculty Development Programs (FDP) at SCOC through IQAC. Academic flexibility is provided to the students by offering various elective subjects. Various add on / certification courses and Student Training Program (STP) conducted in every semester is used to bridge the gap between curriculum and industry. As we follow SPPU Curriculum, there is limited flexibility for electing few subjects as per the choice of students. the college encourages students' participation in Seminar, Workshops, Industry visits, tie-ups through Memorandum of Understanding (MoU) with industries along with technical activities and Value-Added Programs that help students to learn beyond the syllabi. The curriculum designed by the university integrates crosscutting issues relevant to Professional Ethics, Gender, Human Values, Environment, and Sustainability.

Each department frames its academic calendar to nurture students in the right direction for the implementation of curricular, co-curricular, extra-curricular activities. Experienced and dedicated faculty put their efforts to enable students to achieve good academic performance in university examinations. Continuous monitoring of syllabus coverage by individual faculty and assessment of students at every semester contribute to achieve consistent improvements.

The percentage of courses that include experiential learning through project work, fieldwork, or internships is substantial, making our students well-prepared for the industry. The institution also obtains feedback on the syllabus and its transaction from various stakeholders, such as students, teachers, employers, and alumni.

This criterion emphases on innovative teaching methodologies, the use of technology and the best practices in promoting effective learning for the betterment and overall development of the students.

Teaching-learning and Evaluation

The college has a diversified student community from all over India and abroad and provides adequate support to cater their varied learning needs. The college ensures comprehensiveness in admission process by following reservation rules and regulations of State Government and UGC. The student strength of the academic year 2022-2023 is 759 with 221 belonging to reserved category. Different programs are offered to the students according to their competency and choice. Diverse learning levels of the students are assessed to identify slow and advanced learners. Intensive special programmes are organised for addressing learner diversity. The college, in the Academic year 2022-23, has 23 qualified full time teachers out of which seven are having doctorate and one is Research Guide working with full dedication to create zeal, ignite passion and generate curiosity among the students. Academic calendar covering major events and probable examination dates is prepared. Teachers use student-centric methods such as experiential and participative learning which encompasses a variety of activities includes field visits, industry visits, internships, project work, etc. as well as problem solving methodologies in teaching. The college focuses on the use of innovative teaching learning pedagogy and to support it, teachers are well trained to use ICT enabled tools for teaching-learning-evaluation. Mentor-Mentee ratio is optimally maintained for smooth execution of college decorum and student centric learning environment. Internal assessment mechanism is transparent and robust as per the guidelines of Savitribai Phule Pune University. Circular and guidelines pertaining examination and CIE mechanism as well as exam grievances are displayed on the college notice board for students' reference. College practices continuous internal evaluation under CBCS system and observes a prudent grievance redressal mechanism. Programme Outcomes and Course Outcomes are defined, mapped and measured through the evaluation and analysis of students' performance in academics. The outcome of the efforts taken by faculties has increased students' understanding and intellectual ability which has ultimately resulted in good academic performance. Attainment of course outcomes is computed. Online Student Satisfaction Survey is conducted by the institute. Parent teacher meetings are conducted for coordination and communication with the parents.

Research, Innovations and Extension

Sinhgad College of Commerce, Pune, has demonstrated commendable performance in the areas of research, innovations, and extension. Over the last five years, the college faculty members have made significant contributions to the research landscape, with 23 research papers published in recognized international and national journals. These publications reflect the college's commitment to advancing knowledge and disseminating valuable insights in their respective fields.

The college has also made notable contributions to academic literature, with 25 books and book chapters published, all of which have been assigned ISSN numbers. These publications underscore the institution's dedication to knowledge creation and sharing, contributing to the enrichment of the academic community.

Savitribai Phule Pune University funded a minor research project conducted by faculty member, reflecting the

ability to secure research funding and engage in scholarly investigations that have the potential to address relevant societal challenges.

The college has demonstrated a commitment to academic excellence and human resource development by producing six faculty members who are awarded PhD degrees during the last five years.

The college's efforts in community service and societal impact have been recognized by Pune Corporation, which awarded the prestigious "Covid Yodha Award" in 2020 to college. This acknowledgment reflects the institution's active involvement in combating the pandemic and serving the community.

The College has been actively engaged in various social work and extension activities. Celebrating events such as Cleanliness campaigns, Tree plantation drives, Covid vaccination initiatives, and International Yoga Day events demonstrate the college's commitment to community outreach and its dedication to promoting a healthy and sustainable society.

Thus, Sinhgad College of Commerce, Pune, has showcased exemplary performance in research, innovations, and extension. The significant number of research publications, books, and book chapters, along with research projects, exemplify the institution's strong academic and research culture. Furthermore, the recognition and awards received, as well as the extensive community-oriented initiatives underscore the college's dedication to societal welfare. These achievements make Sinhgad College of Commerce a distinguished institution that contributes significantly to the advancement of knowledge and community development.

Infrastructure and Learning Resources

The institute has modern and well-maintained infrastructure and learning resources that provide a conducive environment for effective teaching and learning.

- **Classrooms:** All classrooms in the institute are spacious, well-furnished, and adequately ventilated. They are equipped with desks, benches, platforms, fans, tube lights, green/white boards, LCD projectors, curtains, and LAN/Wi-Fi connectivity.
- **Computing Equipment & Lab:** The institute houses four well-furnished computer labs with 154 computer systems, scanners and printer and 50 Mbps wired internet link. To ensure internal LAN security, licensed software is available.
- Seminar Halls and Smart Classrooms: The College has well-equipped seminar halls and smart classrooms with ample seating capacity, LCD projectors, whiteboards, Sound System with internet connectivity.
- Library: The library is enriched with an extensive collection of 8,474 books and 1,753 titles from various disciplines, 2,927 reference books, N-list E-journals Database and digital library, 432 CDs and newspapers.
- **Training and Placement Cell:** The institute has a well-established Central Placement Cell that facilitates training and placement activities.
- **Faculty Rooms:** The faculty members are provided with individual and/or shared rooms equipped with required furniture and ICT facilities.
- Washroom and Drinking Water Facility: Adequate number of washrooms on every floor along with water purification and cooler facilities, are available.
- Hostel Facility: The institute offers separate hostel accommodations for girls and boys.
- Mess facility: Common Mess facility is provided in the campus for all.

- **Cultural Activities:** The annual 'Sinhgad Karandak' including cultural events is organized along with celebration of Birth anniversaries of Indian Legends.
- Sports and Games and Yoga Center: Provision of facilities for both indoor and outdoor sports and games and Yoga center.
- Gymnasium Hall: A well-equipped Gymnasium Hall is provided.
- **Medical Facility:** The campus has an emergency healthcare center along with STES's Medical College and Hospital, located nearby.
- Other Facilities and Infrastructure Support: The campus has 24/7 power backup generator, stationary stores, Water pump house, Water Harvesting plant, solar system, sewage plant, a canteen, fruit center, laundry, bank with ATM and parking space separate for staff and student vehicles.
- Maintenance: Civil, Electrical, IT, Water and Plumbing maintenance is done regularly.
- Housekeeping: Daily cleanliness and hygiene is maintained by housekeeping team.

Student Support and Progression

The Institution works to help students to develop their personalities in all facets through student-centered instructional methods. Students from foreign nations including Afghanistan, Bangladesh, South Sudan, Nepal, Eritrea and other states in Maharashtra want to apply for admission to the college in order to complete their degree program in the Institute. Students can avail the facility of free ships and government grants. Facility of paying the Fees in installments is provided to the needy students.

Training and Placement Cell offers advice for a variety of competitive tests/exams and job prospects available in various sectors. Each department sponsors a variety of extracurricular events (seminars, workshops, guest lectures, Industrial visits, etc.) that aid students in pursuing careers in their areas of interest. Cell like Women Empowerment, Student Welfare, and NSS make every effort to develop socially conscious citizens. In addition to this, Central Placement Cell of the Parent Institute supports Training and Placement cell of the college in planning training sessions for students' development as well as on- and off-campus hiring efforts.

The college has established Grievance Cell, Anti-Ragging Cell to defend students' rights and address any grievance raised. Student participation in a variety of extracurricular activities as sports and cultural events is encouraged and facilitated by the college's cultural and sports committees. Students actively take part in annual mega fest named Sinhgad Karandak (giant cultural event) and Sinhgad Sports Karandak organized by the Parent Institute. Institutional preparedness for NEP

1. Multidisciplinary/interdisciplinary:	Sinhgad College of Commerce is an affiliated college to Savitribai Phule Pune University(SPPU) which is a state university, it has to follow a road map or guidelines prepared and provided by the State Government. 	citizens are well taken by the institute. IQAC encourages the faculty members to attend the Faculty Development Programmes (FDP) on NEP conducted by University and various institutions. With the guidance of educationalists and academic peers from universities on NEP the faculty members enable to understand the objectives and the phases of NEP 2020. Being an affiliated college HEI provides Inetrdisciplinary education of three Programes for UG viz., B.Com. BBA and BBA(CA). HEI established linkages, collaborations, and signed MoUs to create a multidisciplinary learning ambience through academic and research activities. The institution currently relies on the affiliated university to provide an innovative and flexible curriculum. NEP 2020 has been given priority by SPPU, which also provides community participation services including the National Service Scheme (NSS). Institution promotes Interdisciplinary projects and research for PG students. While we will get more clarity in coming months on how the multidisciplinary and interdisciplinary approach to education being proposed in the policy shape up, we welcome the change and ready to implement in our college.
2. Academic bank of credits (ABC):	The Institution has not registered with ABC which is on the lines of National Academic Depository (NAD). The University is the only one who can register for multiple entry and exits. The choice- based credit system (CBCS) for all programs is fully implemented from the academic year 2019-20 as per the guidelines of UGC and SPPU, Pune. Being an affiliated college, the College follows the CBCS system and the university has a depository for credits in the form of ABC. As per the circular of dated 15.10.2022 by SPPU it is mandatory for students to create an ABC id by registering at http://abc.gov.in/ to digitally store the academic credits earned by students from HEIs. This facilitates students to choose their own learning paths to attain degree/diploma/certificates in context with multiple entry and exits as well as anytime, any-where, and any-level of learning. Now, students have registered with ABC id. Provisions for an Academic Bank of Credit were proposed in the original NEP to allow students to enter and exit their academic programmes at numerous points. This is a novel way to earn and

	save money using national programmes like SWAYAM, NPTEL, and V-Lab. In this provision, it will also be taken into account for credit transfer and accumulation. By these students will be able to earn credits and get the program completed. The Institution shall abide by the curriculum and structure prepared by the affiliating University in this regard. In the CBCS system, a student from the UG stream has to earn 132 compulsory credits from the curriculum and 08 additional credits have to be earned through participation in Sports, NCC, NSS, field visits, study tours, conferences/seminars, AVISHKAR competitions, MOOC courses, and certificate courses for the award of degree. For PG courses in the Commerce streams, a student has to earn 64 credits from the curriculum. In addition to these, each PG student has to earn 10 credits from Human Rights, Cyber Security, Skills Development courses and 2 more credits from Introduction to Constitution for the award of the degree.
3. Skill development:	The curriculum of the Universities and other higher education institutions is being designed in line with the increased demand for skilled workforce in both the public and commercial sectors. Educationists have been adding a lot of skill-oriented courses to the curriculum in recent years. It is imperative to produce a young generation with degrees in their chosen fields and additional skill training that would enable them to launch their own businesses after graduating from college in order to implement the Make in India plan. In this way, a college graduate will shift from being a job seeker to being a job provider. The institution adopted the same mission and in essence followed the parent university's programmes. Being an affiliated college, the institute offers CBCS for UG and PG programs from 2019-20. The curriculum is based on UGC's guidelines and includes skill developing Courses. In addition to the standard skill curriculum from the parent university, the college signed MOUs with various Institutions and industries across all streams in a variety of work culture-related areas For Career Guidance and Placement Cell conducts Guidance workshops on skills required in different industries and organizations and to make them competent for various competitive examinations and placements. Industry personnel are invited to conduct Guidance talks and orientation workshops

	which help to imbibe the skills and enhance the placements. National Service Scheme trains the students in a rational way to imbibe life skills and sensitize them about social issues. Internship and project works to enable students to explore future employment pathways and the overall development of individuals toward nation-building.
4. Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course):	Though the medium of instruction of the entire courses run by the college is English, the college is conducting the functions, extension, and outreach activities with the participation of stakeholders in Marathi, the regional language. Cultural awareness and expressions through the mother language are the major competencies to provide them with a sense of identity, belongingness, and appreciation. This is through the development of a strong sense and knowledge of their own cultural history. In these aspects, NEP 2020 will surely help in strengthening this culture. HEI has established a, language laboratory, a good collection of books in regional Indian languages. Language is linked to art and culture which influence the way people speak with each other in the form of literature, plays, music, film, etc. This couldn't be appreciated without language. The different types of Linguistic competitions are organized through cultural committees. Faculties encourage the students to participate in various debut competition, speech completion, essay completion to express their views without language barriers in English as well regional language. The institution has large number of students from other states, they can show their regional cultural talent through cultural fest especially in Sinhgad karandak- NEON. Indian Knowledge system will include knowledge from ancient India to modern India and clear sense of India's future aspiration with regard to education, health and environment. Teaching of Indian Knowledge System into the curriculum has been initiated by the affiliating University but not by the Institution as Medium of instruction is English in teaching. Indian arts and culture are being encouraged by conducting different festivals and organizing traditional days. To link Indian art- and culture into teaching learning process which will be strengthened. The linkages between education and culture will be carried out through various online

	platforms such as SWAYAM, DIKSHA and will be extended to provide teachers & students with a structured, user-friendly, rich set of assistive tools for monitoring progress of learner. College conducts International Yoga Day every year to preserve the Indian Knowledge among the college students as well as faculty members. It is the aim of college to Preserve and promote the Indian Knowledge in the future.
5. Focus on Outcome based education (OBE):	Outcome based Education (OBE) is a student-centric teaching-learning process in which the course curriculum is delivered to achieve stated objectives and outcomes. OBE focuses on the evaluation of student performance i.e. outcomes at different levels. By having clearly defined Program Educational Objectives, Program Specific Outcomes, and Course Outcomes for the programmes and courses, the institution has built some excellent practices regarding OBE. POs and COs, designed by faculties considering graduate attributes, are stated and displayed on the institution website. The affiliating university, Savitribai Phule Pune University has designed a good strategy for converting its curriculum to OBE, and the institution is fully implementing it. Additionally, the OBE model is used to evaluate every student. The objectives set out in the NEP on OBE are competency, standard, benchmarks, and attainment of targets. In addition to this, the OBE incorporates three elements, Theory of education, a systematic structure of education, and a specific approach to instructional practice. The continuous evaluations of students are carried out by considering aspects of Bloom's Taxonomy with the help of various parameters like Home Assignments, Projects, class tests, viva- voce, seminars, group discussions, end-semester internal examination and subjective assessments. The attainment levels are mapped for various courses and programmes using a well-defined procedure on the basis of performance in examinations. As NEP model is focused on experiential, application-based learning and research- based internship. As a part of holistic education, students will be given internship opportunities with local industries, businesses and local communities.
6. Distance education/online education:	Distance education has not been initiated for the commerce and management courses offered by the affiliating university and as such the institute has no

	such provision. The college follows a CBCS pattern with essential and add-on credits implemented by the affiliating university since 2019-20. The additional credits need to be earned by the students in the stipulated time from various aspects mentioned. 1.1 Curricular Planning and Implementation

1.1.1

The Institution ensures effective curriculum planning and delivery through a well-planned and documented process including Academic calendar and conduct of continuous internal Assessment

Response:

Sinhgad College of Commerce (SCOC) adheres to the academic calendar provided by the University for the Conduction of continuous internal evaluation systems based on Savitribai Phule Pune University Academic Calendar. SCOC prepares its Academic Calendar, which includes dates for the commencement and conclusion of the syllabus, schedules for internal exams, assignments, tentative dates for the semester, etc. Master timetable, departmental timetable, and teachers' individual timetables are prepared and implemented accordingly. The teachers create teaching plans according to the academic calendar, mentioning the teaching methods.

The schedule for university examinations is given by the University and displayed on the notice board for students' reference. In case of any changes in the University schedule, adjustments are made to the internal evaluation, it is communicated to the students well in advance. However, the Institute makes every effort to adhere to the academic calendar for CIE.

Internal exams are conducted as per schedule before university exams. The evaluation of students' home assignments is done on time. Preparatory practical examinations are also conducted. After assessment of the answer books of internal examinations and assignments, papers are distributed among the students and their doubts are cleared. For university practical exams and TYBCOM, TYBBA, TYBBA (CA), SYBBA (from AY 2020-21), project evaluation is done during the exam schedule. Additionally, internship project evaluation is done as per the guidelines of SPPU.

Regular monitoring is done by the Principal and College Development Committee. The Principal reviews curricular, co-curricular, and extracurricular activities and provides remedial coaching regularly to check the execution and progress of the activities in the academic calendar. Based on this review, if required, some changes in the schedule of activities are made. Furthermore, extra lectures are scheduled to complete the syllabus before university examinations.

Moreover, teachers conduct students' seminars and group discussions. The academic calendar provides a particular schedule for extracurricular and extension activities such as the celebration of birth and death anniversaries of national icons, various national and international days, Tree plantation programme to keep campus areas green and create awareness, awareness programme on various environment-related issues, blood donation camps, hemoglobin level determination camps for rural women, and various other social activities are conducted by NSS.

The academic calendar indicates the annual working period of the teachers, which includes working days, teaching days, admission period, examination, and valuation period, as per the university and UGC

guidelines. The total working days, as provided by the university, are around 240 days, out of which 180 days are reserved for teaching work, and the remaining days are used for co-curricular and extracurricular activities. Working days are strictly followed as per university guidelines.

The Institution believes that integrating cross-cutting issues with the curriculum would create positive impact on the students both in terms of their education and societal commitment. The institute conducts awareness sessions and related activities. The college itself puts emphasis on inculcation of these cross-cutting issues. The faculty takes efforts to make the students aware of these issues in all respect.

Gender Sensitization: The growing importance of gender equality is communicated effectively to the students through add on courses. The students are acquainted with the concepts of feminist relationships, responsibilities and gender identities. Women empowerment and gender equity is inculcated among the students with guest lecture. Various activities conducted by NSS, Sports and cultural committee of the college, e.g. Women's day, self defense programmes for girls. The students are informed about the legally enforced gender equality policies that are mandated in all work places. The students are addressed in bilingual languages and different styles of communication to ensure complete understanding. The institute has established the Grievance Redressal Cell, Anti Ragging Cell, Anti Sexual Harassment Cell etc. to sensitize the students and employees on gender issues and make them aware of the social, moral and legal implication of gender discrimination. The college maintains an environment which is free of gender discrimination.

Environment and Sustainability: The courses in Environmental Awareness Studies (SY B. Com., BBA and BBA (CA)) are offered by the University. These courses act as the bridge between educational skills and human values. These courses also facilitate holistic development of all students forming a basis of value-based life. They ensure a positive perspective towards life, career and happiness among students. Human values are also inculcated among the students through different activities conducted by NSS, Sports and cultural committee of the college.

Professional Ethics: The professional and non-professional courses are offered by the university to develop the professional ethics among the students and to make them aware about different career options. In addition to degree courses, some skill-based courses like Tally, Financial literacy, communication skills etc. also develop different skills and professional ethics among the students. Professional Ethics are also instilled among the students through counseling cell, Placement cell, commerce association, and guest lecturers organized at different occasions.

2.3.1

Student centric methods, such as experiential learning, participative learning and problem solving methodologies are used for enhancing learning experiences and teachers use ICT- enabled tools including online resources for effective teaching and learning process

Response:

The Sinhgad College of Commerce adopts a Student Centric Approach to develop joyful learning, nurturing creativity, sustainable development and developing accountable, proactive citizens and leadership with high ethical standards. Various curricular, co-curricular and extra-curricular programs are planned and organised accordingly. The college has student centric approach to make learning a personalised experience in which students engage themselves in different skill-based and competency-based activities. The college has developed a Mentor-Mentee system for solving student's academic as well as other problems. The college also emphasizes on using ICT enabled tools for effective teaching-learning process.

Experiential Learning is the process of learning by doing. By engaging students in hands-on experiences and reflection, they are better able to connect theories and knowledge learned in the classroom to real-world situations. Experiential learning opportunities exist in a variety of course and non-course based forms. Our faculties take efforts to bridge the gap between individual and industry by providing experiential learning experiences to our students. Course based experiential learning includes add on courses like artificial intelligence and machine learning, python basics and installation, bridge course like fundamental concept of mathematics, disaster management, Certificate Courses, etc. Non-course based experiential learning includes student training programme (STP), internship, PPT presentation, participation in NSS, cultural events and other competitions.

Participative learning is an approach to teaching and learning which focuses on the learner. Participative learning empowers the students to become independent learners. Our college organizes various events, activities and competitions like speech competition, Poster competition, Best from waste competition, Group discussion, hosting programms, etc. in which our students do participate. This helps the students to develop analytical, technical, communication, competitive and presentation skills.

Problem Solving Methodologies are processes through which a situation or issue may be analyzed and solutions implemented. We assign Cases or Articles of Harvard Business Review and Indian Institute of Management (IIM) to students to solve the problem on their own and come up with a solution. Aptitude, Logical and reasoning tests, excel module, GK&CA, Group Discussion, etc., are conducted under Student Training Programme (STP). Students are also assigned projects to prepare on their own. Also conducted various guest lectures on goal setting, career guidance opportunities, GST etc.

The college has developed good ICT enabled facilities such as well developed Computer Labs and Digital library /E-library interconnected with LAN. Teachers use LCD projectors for enhancing teaching-learning process. Teachers also use google classroom, drive, and whats app for sharing notes, study materials etc., for better access. The college also encourages teachers to attend training programmes, Faculty Development programmes, Faculty Improvement programmes, conferences, seminars and workshops, etc., related to the ICT use and innovation in teaching-learning. Digital libraries and repositories utilise OPAC and ICT to provide online access to a wide range of digital resources which include e-books, e-journals, audio visual materials and other digital content for enhancing advanced knowledge of faculties and students.

- CBCS for UG courses has been effected by SPPU under 2019 Design. It has been actualized to F.Y.B.Com, F.Y.BBA and F.Y. BBA(CA) from the academic year 2019-20.
- CBCS pattern for PG courses has been implemented by SPPU under 2013 pattern.
- Under CBCS, examination of the all courses is conducted within the framework of Projects , Multiple Choice Test , Presentations , Assignments , Unit Test , Group Discussion, Interviews, etc.

The college academic calendar is prepared at the beginning of the academic year. This includes the academic activities conducted at the college level. The same drafted calendar is approved in Principal's and HOD's meeting. A schedule of internal assessment is designed in the academic calendar and all the internal assessment tests are conducted at the college level accordingly.

- Program structure, CIE design, and weightage of internal assessment is communicated to students at the starting of the academic year by each subject teacher.
- Internal assessment modules are distinctive for different programs.
- The time tables, seating arrangements of respective examinations are shown on the notice board of the college and also shared with students through whatsaap group.
- Internal supervisors are allotted for smooth conduction of examination.
- Generated question papers are securely conveyed to the student at the time of examination under

the observation of the CEO and Chief Conductor.

• Classwise marks of subjects are compiled by class teachers. The compiled marks sheet records of internal examinations are displayed on notice board and circulated among students in time.

Grievance mechanism For Internal and External Exams

- The college has formed a College Examination Grievance Committee, which is headed by College Examination Officer (CEO) nominated by the Principal.
- The CEO shoulders various responsibilities to handle different issues occurring during Internal and University examinations.
- As per the rules and regulations, grievances related to examinations are carried out and the solution is given immediately. The College Examination Grievance Committee deals with grievances with the help of concerned HOD and faculty members and resolves the issue. This process is generally completed in given time.
- The student approaches the HOD with a written application, the HOD consults with respective teacher about the issue and resolves it.
- The students have right to redress their grievances related to internal examination such as error in marks of internal tests, assignments, presentations, etc. to the college examination committee.
- Students' grievances related to university examination are forwarded to the university examination department by the proper channel for the further action.

throughout the semester of the academic year. The faculty records the performance of each student with the help of the specified course outcomes through a continuous evaluation process. The faculty provides home assignments to students, conducts internal tests and project presentations.

Some of the key indicators of measuring attainment are:

• End Semester University Examination:

Sinhgad College of Commerce is affiliated to Savitribai Phule Pune University, Pune. The college offers under graduate and post graduate courses under the faculty of commerce. For these programs and courses, the institute follows the curriculum designed by affiliated university. The Programme outcomes and course outcomes are evaluated by the institution and the same are communicated to the students in the formal way of the discussion in the classroom. After measuring attainment of POs and COs, it has been observed that the strength of the students as well as passing percentage of the students are increasing gradually. Besides, students' progression to the higher studies i.e. from under graduate to post graduate seems to be increasing consistently in the last five years.

• Internal Assessment:

The Internal Assessment carries 30% weightage of the total marks (100) for each subject. The students are given assignments which are designed in alignment with Programme Outcomes of the respective subject. Additionally, internal/class tests, viva etc. are conducted frequently in a semester to evaluate the performance of students on a regular basis.

• Practical Assessment/ External Assessment:

It is carried out by inviting external experts appointed by the university to evaluate each student by conducting Practical examinations, Viva and checking the practical files.

• Result Analysis:

At the end of each semester, result analysis of each course/class is carried out indicating the percentage of passed and failed students along with topers of the class. This is an effective indicator in order to evaluate the level of attainment of Pos and Cos.

• Internships and Placements:

Students are encouraged to take up internships, projects, fieldwork, etc. The Placement Cell of the college helps and polishes the students according to industry standards and provides ample opportunities to get placed in esteemed companies. This helps them to obtain necessary skills and practical experience in their chosen discipline.

4.1 Physical Facilities

4.1.1

The Institution has adequate infrastructure and other facilities for,

- teaching learning, viz., classrooms, laboratories, computing equipment etc
- ICT enabled facilities such as smart class, LMS etc.

Facilities for Cultural and sports activities, yoga centre, games (indoor and outdoor), Gymnasium, auditorium etc (Describe the adequacy of facilities in maximum of 500 words.)

- **Classrooms:** All the classrooms in the institute are furnished, capacious and equipped with desks, benches, platform, fans, tube lights, green board/whiteboard/ blackboard, LCD projector, curtains, and LAN/Wi-Fi connectivity.
- **Computing Equipment & Lab:** The institute has four computer labs which are well-furnished with required carpet areas, proper lighting and ventilation. There are 140 computer systems with required softwares installed. Additionally, sufficient supporting equipments like scanners and printers are available. The campus is connected to Tata Tele business service devices through VLAN providing internet facilities with a bandwidth of 50 Mbps via a wired link to connect internal LAN as per the requirements. The computer labs are permitted to remain open beyond college working hours for staff and students.
- Seminar Halls and Smart Classrooms: The college has well-equipped seminar halls and smart classrooms with adequate seating capacity. These facilities include LCD projectors, whiteboards, platforms, and a public-address system with internet connectivity making them suitable for big gatherings in the department.
- Library: The library is enriched with a total number of 8,474 books and 1,753 titles covering various current and syllabi-based books from all disciplines of Commerce, Management, Information Technology, 2,927 reference books, 68 bound volumes and an N-list E-journals Database. Moreover, there are 432 CDs available as offline databases. English and Marathi newspapers are also made available in the library.
- **Training and Placement Cell:** A well equipped Placement Cell is established to carry out training and placement activities.
- **Staff/Faculty Rooms:** The institute provides individual and/ or shared staff/faculty rooms equipped with the necessary furniture and LAN connected computer systems.
- Washroom and Drinking Water Facility: The number of adequate gents and ladies washrooms are available on each floor along with water purification and cooler facilities. A central water pump house to supply water to different buildings on campus is available.
- Hostel Facility: Separate hostels for boys and girls are available with adequate facilities.
- Mess Facility: Mess Facility is available forhostel students as well as others.
- **Cultural Activities:** The annual 'Sinhgad Karandak' cultural fests is a platform for students to showcase their talents in performing Cultural, arts and technical events comprising competitions, and stage performances, attracts participation from various colleges including international students.

- **Sports and Games**: The institute provides facilities for organizing both indoor and outdoor games. Outdoor sports include cricket, lawn tennis, football, volleyball, basketball, and Kabaddi while indoor sports include table tennis, carom board, and chess.
- **Yoga Center:** The institute celebrates International Yoga Day every year on 21st June. Yoga and meditation sessions are conducted for students and staff on the premises through NSS and Sports unit of the institute.
- Gymnasium Hall: The institute has a separate, well-equipped Gymnasium Hall with fitness, strength, endurance, and power-related equipment.
- **Medical Facility:** The campus has an emergency health care center Medical College and Hospital, nearby.
- Other Facilities: The campus also has Stationary stores ,power backup generator house, central water pump house, Solar System, parking facilities for staff and students' vehicles, staff quarters, guest house, canteen, fruit center, laundry, and a bank with an ATM.

4.2 Library as a Learning Resource

4.2.1

Library is automated with digital facilities using Integrated Library Management System (ILMS), adequate subscriptions to e-resources and journals are made. The library is optimally used by the faculty and students

Response:

The Knowledge Resource Centre (KRC) is not just a collection of resources; it is also a reservoir of knowledge. The College Library is a spacious, well-equipped hub of learning that inspires and provides teachers and students with the required resources and research facilities. The Library is located on the 3rd floor of the Admin building, covering a carpet area of approximately 260 sqm. which includes E- Library and Reading Room with a carpet area of approximately 171sqm with a seating capacity of 200 readers (students and staff). The Library is well-developed and well-maintained with a collection of around 8474 books, including reference books, textbooks, encyclopedias, bound volumes and study material on different domains and fields of General knowledge as well as for additional reading. The resources are arranged subject-wise and classified according to the Due Desimal Classification System. Additionally, the library regularly subscribes leading newspapers and Journal/ Periodicals. The college has subscriptions to around 27 periodicals including national and international core journals, popular magazines from in the field of Management, Marketing, Accounts, Economics and Computers etc.

E- Subscription:-

The Library has a membership with INFLIBNET-N-List which allows access to e-books and e-journals. N-List offers a vast collection of more than 3,135,000 e-books and more than 6,000 e-journals as well as access to Shodhsindhu and Shodhganga. This information is regularly restocked to provide sufficient learning resources for students.

Library Automation:-

Library is automated with Library Software. The Library is managed using two Integrated Library Management System (ILMS) softwares Autolib and Online KOHA - Library Management System. It is fully automated with Autolib version 1.0.0 implemented on 3rd October 2009 and KOHA version 22.11.04 implemented on 21st February 2023. The Web OPAC (Online Public Access Catalog) deals with the Catalogue and Search, allowing users to search for books based on bibliographical details such as Title, Author, Subject, Place of Publishing, Publisher, Year of Publishing, Classification Number, ISBN Number, Editor. The Catalogue includes precise details and the status of the books available in the library.

4.3 IT Infrastructure

4.3.1

Institution frequently updates its IT facilities and provides sufficient bandwidth for internet connections. The institution maintains an adequate and continuously updated IT infrastructure in accordance with curriculum requirements and evolving technology. There are enough computer switches and Wi-Fi facility along with the required software.

The department's computer labs and central computing facilities are interconnected through proper networking allowing internet access. These computing facilities are utilized for academic purposes, training, value-added courses, research and other activities following the timetable and accommodating special requirements even beyond working hours. The college has switched to a high availability network ensuring information and network security through the Sonic Wall NSA4600 firewall. Simultaneously, 154 users can login, there is internet connectivity of 50 Mbps from Tata Tele services which provides a total bandwidth of 50 Mbps to faculty and students throughout the year.

The Institute is Wi-Fi enabled with high-speed internet connectivity. Wi-Fi access points are connected to switches in a LAN forming a structured LAN facility architecture comprising core, distribution and access. All end users are connected through 10/100 base ports and the Institute's network is secured with a firewall.

ICT facilities are available in all classrooms, laboratories and the library providing both internet and intranet access. Each classroom is equipped with a computer, LCD projector, and internet access. CCTV cameras are strategically installed for security purpose. The College operates one server for smooth conduction of various activities such as online examinations, webinars, online workshops and administrative functions with uninterrupted power supply. Desktop computers connected with the internet are provided in all departments and laser printers are available as well. Curriculum based software is regularly updated each semester to stay up to date.

The Institution has a Language lab to enhance students' communication skills and ICT Tools for conducting online classes and meetings. Necessary system and application software are available in all respective laboratories classified as proprietary software and open-source softwares. Proprietary system softwares are purchased at the society level and distributed to different institutes while application softwares are procured individually for departments based on their curriculum and needs. The Institution encourages the use of open-source softwares, tools and applications to reduce dependency on proprietary alternatives and to support the teaching-learning process.

The college library is automated with AUTOLIB and KOHA softwares, using OPAC System utilizing cloud server facilities. The library also has subscriptions to e-books and e-journals through N-List developed by INFLIBNET.

Residential facility is available for both teaching and non-teaching staff members based on availability. The institution boasts a variety of amenities on campus including a gymnasium hall, sports ground, lawn tennis court and emergency services like generator backup for the college and staff quarters. The estate office plays a crucial role in maintaining these facilities.

Furthermore, the campus offers supporting and essential services such as nationalized bank, ATM and a stationery shop. For the appraisal of teaching and non-teaching staff, the college has well-defined systems. Teaching staff is assessed based on four categories namely Student Centric Activities, Professional Development and Academic Contribution, Research Contribution and Assessment by the Head of the Department and forwarded to the principal then to the management for further assessment. To manage procurement in a transparent and cost-effective manner, the college has established a separate Purchase Committee. This committee collects requirements from all departments and gathers quotations from potential vendors/suppliers. Based on the lowest quotation, the committee negotiates rates to ensure quality and cost-effectiveness while adhering to the allotted budget. Each department and committee proposes budgets for co-curricular and extracurricular activities during the CDC meetings. Sports materials and stationary are purchased in bulk after careful analysis of annual requirements to maximize cost-effectiveness.

To ensure financial transparency and accountability, the college undergoes a three-tier audit system. This includes internal ,external and statutory audits. External and statutory audits are conducted annually to ensure compliance with regulatory requirements and obligations set by the parent institute and SPPU. The internal audit carried out by an auditor appointed by the parent institution (STES), aims to monitor the financial management of the institution and ensure a sound financial position. This audit involves verifying various financial documents, such as cash books, bank statements, entries in the tally software, vouchers, fee registers and cheque registers.
